Diploma in Investment Operations

What is the Diploma in Investment Operations?

The Diploma in Investment Operations is widely acknowledged as the most appropriate qualification for staff wishing to pursue a career in investment operations. It offers individuals the opportunity to specialise in the administration of investment funds and custody and settlement and gain a broad understanding of the wider financial environment. It will enable staff to demonstrate their knowledge and skills and pursue a senior management role within investment operations.
