### How is the qualification structured?

The qualification consists of two parts, an exam and a case study, which must be achieved in this order:

## Entry requirements

To be eligible to start this qualification, you must first hold an RDR-compliant qualification for FCA Activities 4 and 6 (with gap-fill if required). This can be either:

**Investment Advice Diploma** (Financial Planning & Advice)

or

An RDR-compliant qualification for FCA Activities 4 and 6 (with gap-fill if required)

## Exemptions

An exemption from the level 6 Certificate in Advanced Financial Planning exam is available to holders of the full CISI level 6 Diploma in Financial Planning.

After an exemption is obtained, you will only need to complete the level 7 Financial Plan Case Study to achieve the level 7 Diploma in Certificate in Advanced Financial Planning. Contact fpexams@cisi.org for more information.
