



## CISI MASTERS, CISI DIPLOMA, ICAEW/CISI DIPLOMA IN CORPORATE FINANCE & CISI ADVANCED CERTIFICATES MARKS ANALYSES JUNE 2014 EXAMINATION

The panel decision on grades awarded is final and it is not the policy of the Institute to disclose marks achieved. Although no correspondence will be entered into with candidates regarding their examination results, a marks analysis is available for June 2014 examination candidates graded marginal fail and fail. This will be a brief overview highlighting main areas of weakness and does not answer the examination questions nor comment on script contents. It is a review of the marks achieved identifying where low marks were awarded and should be read in conjunction with the Chief Examiner's Report. This service is only available to candidates.

The charge for this service is £25.00 per script. Requests must be in writing to the CISI giving full name and candidate number by 30 September 2014.

**REQUESTS RECEIVED AFTER 30 SEPTEMBER 2014 WILL NOT BE ACCEPTED**

This service will be provided under the following conditions:

- This will NOT constitute a remarking exercise
- This service is not retrospective (i.e. not applicable to any exams before June 2014)
- The service is available only to candidates who were awarded marginal fail or fail
- Actual marks gained overall or marks per question will not be disclosed
- Candidates' scripts will not be returned to them under any circumstances
- Up to four weeks should be allowed for the return of the analysis upon request received by the Institute
- The Institute will not enter into further correspondence on grade achieved.

Candidates requesting a review are deemed to have accepted the conditions stated above.
