



The CISI Mentor of the Year Award 2025

- 1. The CISI Mentor of the Year Award ("the Competition") is being conducted by the Chartered Institute for Securities & Investment (CISI), 20 Fenchurch Street, London, EC3M 3BY.
- 2. To be eligible for the Award, both the nominating mentee and mentor must:
 - i. Be current members of the CISI
 - ii.Be up to date with their membership subscription payments
 - iii. Have had a mentoring relationship together using the CISI Mentoring Scheme since October 2023
 - iv. Be active members on the CISI Mentoring Scheme
 - v.Not be under any disciplinary action or investigations
 - vi.Not be a current CISI Trustee
- 3. Mentors may not nominate themselves for the Award.
- 4. If more than one mentee nominates the same mentor, then each entry will be considered on its own merits (the nominations will not combine or stack) and the highest scoring entry will be taken.
- 5. Mentors will only be notified that they have been nominated for the award if:
 - 1. They progress to the second round of the Competition (see section 7)
 - 2. They submit a request to CISI for their personal information.
- 6. The 2025 Competition applications (i.e. fully completed entries) must be submitted in accordance with these terms and conditions by the closing dates as outlined below.
- 7. The stages of the Competition are as follows;

First round: Complete the application form (answering all questions) and submit online by 11:59pm on 15 November 2024.

An internal team of CISI representatives will review the applications and shortlist applicants to progress. Entries will be judged on the responses submitted exclusively. Successful applicants will be notified of the outcome of the first round by **31 December 2024**.

Second round: The top shortlisted Applicants will be invited to attend an interview with a Judging Panel (the Panel) comprising CISI representatives in **January 2025**. This will take place via video call. The Panel will select an overall Winner.

- 8. The CISI accepts no responsibility for incorrectly submitted, delayed, misdirected or illegible entries into this Competition.
- 9. Mentors may be provided with a copy of the mentee's submission.
- 10. Mentors that progress to the second round may have their details published on the website and in various industry publications.
- 11. The winning Mentor and nominating Mentee will be invited to attend the 2025 CISI Annual Awards Ceremony
- 12. The winning Mentor and nominating Mentee's details will be published on the website and in various industry publications.
- 13. General feedback by way of comments from the Panel for the second round will be made available on request once the Winner has been announced. No feedback will be given regarding entries that did not progress to the second sound.
- 14. The Winner will receive:
 - i. Feature on the CISI website.



- ii. Profile on CISI social media channels.
- iii. Announcement in The Review.
- iv. Digital Mentor of the Year 2025 badge
- v. A trophy awarded at the CISI Awards ceremony and the accolade of winning.
- 15. The Winner must take the prizes as specified above. Where applicable, the prizes cannot be redeemed for cash, exchanged or transferred to another person.
- 16. Chance plays no part in this Competition. The Panel's decision is final, and no correspondence will be entered into. Any applicants or applications not complying with these terms and conditions or involving fraud or any other illegal activity may be disqualified by the Panel and/or replaced by another applicant at any time. The CISI reserves the right to undertake at any time any verification checks of the application submitted.
- 17. By entering the Competition, all applicants confirm and agree that they will abide by these terms and conditions, they are the person who submitted the application, and the application is their own work.
