Paraplanner of the Year Award 2017 The Financial Planning Annual Conference & Gala Awards

Terms and Conditions



- 1. The Paraplanner of the Year Award or PPOTY Award (the "Competition") is being conducted by the Chartered Institute for Securities and Investment (CISI), 20 Fenchurch Street, London, EC3M 3BY
- 2. Entry to the Award is open to all residents of the UK and Northern Ireland who are currently working as a paraplanner in a Financial Planning firm, in a freelance or outsourced capacity.
- The 2017 Competition opens for registration from 5 June 2017. Applications (i.e. fully completed entries) must be submitted in accordance with these terms and conditions by the closing time/date of Monday 21 August 2017 at 9am.
- 4. To enter the Competition, applicants must:
 - Submit a response to the online case study in no more than 2,500 words which has been created by the CISI (answering all the questions) to <u>FPAwards@cisi.org</u> by the closing date of Monday 21 August 2017 at 9am.
 - b. Be available for an interview in person at CISI offices, 20 Fenchurch St, London on the morning of 14 September 2017.
- 5. Applicants may only enter the Competition once. CISI accepts no responsibility for incorrectly submitted, delayed, misdirected or illegible entries into this Competition.
- 6. A panel of judges ("The Panel") consisting of representatives from the CISI and the paraplanning community will review the applications and select the winner. Entrants will be judged according to their response to the case study. The top two shortlisted entrants will be invited for an interview to determine the overall winner. General feedback by way of judges' comments will be made available after the awards are announced at the conference.
- 7. The winners' and their details will be subsequently published on the CISI website and in various industry publications following announcement at the CISI conference.
- 8. The Winner will receive:
 - a. Registration and a full pass to attend the CISI Financial Planning Annual Conference 2017. If the winner has already booked their place for 2017, the free place will be carried over to the 2018 conference.
 - b. Two nights of hotel accommodation at the 2017 conference. As above, if the winner has already booked accommodation for 2017, the accommodation will be carried forward to the 2018 event.
 - c. Framed Certificate

Applicants who submit multiple entries will be judged on their first entry only.
