

# Expired SPSs

You can renew your SPS online up to 45 days after your SPS has expired. If your SPS has expired, beyond 45 days the status of your application will be set to 'Expired' and you will be unable to renew your SPS online. To renew your SPS, you will be required to complete and return a manual SPS renewal form to spsapplications@cisi.org.





# APER/COCON Requirements & CISI Code of Conduct

You will be required to confirm your adherence to either the FCA APER requirements or the FCA COCON requirements. This is dependent on whether your firm now fall under the new Senior Managers Regime as to which is applicable.

You will also need to accept the CISI's Code of Conduct by selecting a check box for each statement. If you do not select these check boxes, your application cannot be processed.



### Declaration and SPS Terms and Conditions



### Application Submission

Once you've submitted your application, you will receive email notification advising you that your application has been approved by the CISI.

If you have made changes to any of your details, your application will be submitted to the CISI for review. You will receive notification via email once your application has been approved by the CISI.

If your employer has indicated that firm verification is required, then your application will be sent to the nominated firm verifier(s) for approval before it will be processed by the CISI. You will receive notification of this via email. Notification will also be sent to you via email once your firm verifier(s) has approved your application.
